PLAYA DEL CARMEN GETAWAY GUIDELINES

PROMOTION OVERVIEW

The top 300 Distributors who earned most points (over a minimum of 125 points) during Qualification Period will qualify for the 2017 Playa del Carmen Getaway Package.
